#### Life-Study of Matthew – Study Guide

Dear brothers and sisters.

We will continue this week's truth pursuit with Message 20 of the *Life-study of Matthew*, entitled The Decree of the Kingdom's Constitution (8). This life-study covers Mattrew chapter 5 and focuses on 5:48. The main burdens are to help us develop a clear understanding of the law by knowing the three aspects of the law, living by the father's life and name, fulfilling the righteous requirement of the law by walking according to the spirit, and seeing how our spirits are formed. We also need to know that we are not only God's creatures, but also His regenerated children. There is no time element with God.

Here is an excerpt from this message followed by key verses for pray-reading and questions for your study:

At this point we need to consider some verses in Romans 8. Romans 8:3 says, "For what is impossible to the law, in that it was weak through the flesh, God sending His own Son in the likeness of the flesh of sin and concerning sin, condemned sin in the flesh." Due to the weakness of our flesh, it is impossible for us to fulfill the law. We can do nothing. As far as the law is concerned, our case is impossible. Therefore, God, sending His own Son in the likeness of the flesh of sin and concerning sin, condemned sin in the flesh, so that "the righteous requirement of the law might be fulfilled in us, who do not walk according to flesh, but according to spirit" (v. 4). Because it was impossible, due to the weakness of our flesh, for the law to be fulfilled, God sent His Son to keep the law on the positive side, and to die for our weakness on the negative side. His purpose in doing so was that the righteous requirement of the law might be fulfilled in us. The "us" in verse 4 refers to those who do not walk according to the flesh, but according to the spirit. God sent His Son to keep the law and to die for us that we may walk in the spirit to fulfill the righteous requirement of the law. Key Verses for pray-reading: Matt. 5:48; Rom: 8:3 - 4, 14, 16.

#### Questions:

- 1. What are the three aspects of the law? Since the principle of the law and the rituals of the law have been terminated, why do we still need to be concerned with them? What does it mean for the principle of the law to be abolished in Christ under the dispensation of grace?
- 2. At the end of Matthew chapter 5, the Lord tells us that we should be perfect as our Father. However, we realize that we cannot fulfill any requirements on our own. So, how can we meet the Lord's standard?
- 3. According to this message, please explain how living by the Father's life and name, and fulfilling the righteous requirement of the law, can become our experiences today.
- 4. According to this message, what do Romans 8:16 and 8:14 reveal, what do they indicate, and what is the spiritual significance behind these verses?
