Life-Study of Matthew - Study Guide

Dear brothers and sisters,

We will continue this week's truth pursuit with Message 24 of the Life-study of Matthew - "The Decree of the Kingdom's Constitution (12)". This life-study covers Matt. 7:13-29, concerning the ground of the kingdom people's living and work.

Here is an excerpt from this message followed by key verses for pray-reading and questions for your study:

"...We must be deeply impressed with the fact that the constitution of the kingdom of the heavens is based upon the divine life and nature of the kingdom people...only the kingdom people can live according to it. Moreover, not even the kingdom people can fulfill the requirements of this constitution if they do not live according to the divine nature and the divine life within them...

This constitution firstly reveals the nature of the kingdom people, as unfolded in the nine blessings in 5:3-12...By the time we reach 7:12, nearly every aspect of our living and behavior has been covered. It seems that the constitution is now complete, perfect, and all-inclusive.

However, one thing remains to be covered: the fact that the kingdom people are on earth doing the will of God our Father...the conclusion of the constitution of the heavenly kingdom ushers us through the narrow gate and to the constricted way; thus we may do the will of the heavenly Father and we may build a house.

As we consider the constitution of the kingdom of the heavens as a whole, we see that it fully reveals what the kingdom people are, what they should be, and what they should do. It also reveals where they are and where they are going..." (Witness Lee, *Life-study of Matthews*, Living Stream Ministry, Anaheim, CA, msg. 24, pp. 295 - 297).

Key Verses for pray-reading: Matt 7:13-14, 21, 24.

Questions:

- 1. What are the four crucial words of the heavenly King in the last section of the constitution? What kind of people are those who enter through the narrow gate and walk on the constricted way?
- 2. Consider the example of the Lord Jesus in John 7:1-10. As one in the Lord's recovery, are you walking in the spirit, on the constricted way? How can we apply this to our fellowship with the saints in the church life?
- 3. What is the requirement of entering into the kingdom of God? What are the requirements of entering into the kingdom of the heavens? What is the Father's will in Matthew 16:18? Who are "Workers of lawlessness" in Matthew 7:23?
